The text should be clear, concise, and written in proper English. The content must contain relevant and new information. Significant technical information must not be withheld. Abstracts should contain results.

STRUCTURE OF THE ABSTRACT

Abstracts should be structured and should include:

- Authors' names and affiliations
- Title
- Background / Aims
- Methods
- Results
- Conclusions

Abstracts are limited to **2500** characters, spaces included (title, authors' names and affiliations excluded).
